

# Edward Alleyn's Diary and Account Book, 1617 to 1622

## Glossary of Names

by Prof. Grace Ioppolo and Patrick Darby

This Glossary records all names of persons with whom Alleyn notes in the Diary that he had a personal or professional relationship. As Alleyn is not always precise in writing people's names or in noting their relationships to him, the names in his Diary have been checked against those listed in George Warner's *Catalogue of the Manuscripts and Muniments of Alleyn's College of God's Gift at DC* (1881) and the Second Series of the same catalogue completed by Francis B. Bickley (1903), as well as William Young's *The History of DC*, 2 volumes (1889). In addition, in the cases in which Alleyn gives both the surname and forename, the names have been checked against an online database of residents mentioned in Southwark Token Books (<https://tokenbooks.folger.edu/>) prepared by Alan H. Nelson and William Ingram. Throughout, 'DC' is an abbreviation for Dulwich College; all references to DC MSS and Muniments specifically refer to the Alleyn Papers.

Entries in red are by Prof. Grace Ioppolo. As at 27th June 2025, this Glossary is very much a 'work-in-progress', but will be up-dated as soon as possible.

## A

**Abbot, George.** See **Canterbury, Lord of**

**Abdy :** Humphrey Abdy, gent., of Streatham. Alleyn's lessee of Kennalls (6 acres) and another 2 acres, and of part of Newlands (3 acres). Died 1626.

**Adayes, Mr :** see **Adye, John.**

**Adey or Adye, John :** a lawyer, and a Southwark resident. Alleyn dined with him on 22/9/1619, and paid him 10s on 21/7/1619 for advice about Jacob Meade, and four lots of 5s on 3/12/1621, 24/12/1621, 7/12/1622 and 14/1/1622 in connection with a trial of Jacob Meade.

**Albert:** a joiner. Alleyn paid him £2 11s 10d and 10s 4d on 23/5/1618 for various joinery works at DC.

**Alexsander, William :** Dined with Alleyn on 24/7/1621. Prince Charles' gentleman usher; later Sir William Alexander, later Earl of Stirling; addressed a poem to Alleyn in DC MSS 1, Article 137.

**Alldrige, Mr :** Dined with the Alleyns on 24/1/1619.

**Allen, Anis or Anne ('Nan') :** Alleyn's relative, who entered his service on 6/10/1619 at 10s a quarter, and left it on 3/10/1620, having secretly married John Harrison, 3rd fellow of DC.

**Allen, Captain :** Dined with Alleyn on 13/9/1620.

**Allen, Frances :** see **Allen, Frances.**

**Allen, Francis :** see **Allen, Francis.**

**Allen, Isaac :** see **Allen, Isaac.**

**Allen, J :** Alleyn bought 6lbs of sugar from 'J [or possibly I] Allen' for 5s on 4/12/1617.

**Allen, 'Jugg' :** Alleyn's pet-name for **Joan Alleyn, daughter of Thomas Alleyn, the first Master of DC**, but also (e.g. in 1593) for his own wife Joan.

**Allen, Mr :** described by Alleyn as a goldsmith; possibly the goldsmith Francis Allen (c.1583–1658), later a Member of Parliament who participated in the prosecution of King Charles I who was executed in 1649. A Mr Allen dined with Alleyn on 23/11/1617, and again (with 'Mr Allens sone') on 7/12/1617.

**Allen, Robert :** As Alleyn lists him as an Irish preacher, he may be Robert Allen, a Church of England clergyman and religious writer, who published *An Alphabet of the Holy Proverbs of King Salomon* (1596), *The Doctrine of the Gospel* (1606), and *Concordances of the Holy Proverbs of King Salomon: and of his Like Sentences in Ecclesiastes* (1612), among other works. The *Oxford National Dictionary of Biography* states that there are no further references to him after 1612, but he appears to have been in London during the periods in which he visited Alleyn.

**Allen, Sergeant :** Alleyn paid 'sarjant Allen' 4s 4d for a denshiring iron on 24/3/1619[20].

**Allen, Sheriff ('Shreeue') :** **Edward Allen**, Prime Warden of the Fishmongers Company 1620, Alderman, and **sheriff of London** 1620-1621.

**Allen, Thomas.** See **Alleyn, Thomas.**

**Alleyn, Edward ('Ned') :** a 'poor fatherless' child whom Alleyn fostered from 27/1/1620[21].

**Alleyn, Elyas :** possibly **Elias Allen (c.1588–1653)**, who became famous as a maker of mathematical instruments; probably (according to Young) father of an **Elias Allen** mentioned in 1642 as a later competitor for the wardenship of the College in DC MSS 6, f. 27, and was Warden in 1677.

**Alleyn, Frances :** daughter of **Mathias Alleyn**. Baptised 26/1/1618[19]; buried 6/2/1618[19].

**Alleyn, Francis :** On 15/8/1618 Alleyn paid Francis Allen 6s for 6 days' reaping. (One more day was given free.)

**Alleyn, Isaac** (not ‘Jisack’) : Isack Allen dined with the Alleyns on 5/2/1617[18], stayed with them on 27/4/1621, and he, his wife, a friend, and his son Jacob dined at Dulwich on 2/6/1622.

**Alleyn, John (‘Jack’)** : DC Warden, 1669 and Master, 1678; he died in 1686.

**Alleyn, Joan** (also called ‘J.A.’ and sometimes ‘Jug’) : Joan Alleyn, née Woodward, daughter of Henry Woodward and Anne or Agnes Woodward, and step-daughter of Philip Henslowe, married Edward Alleyn in October 1592.

**Alleyn, Judith** : daughter of Mathias Alleyn. Buried 28/6/1618.

**Alleyn, Matthias** : tailor. Warden of DC from 1619; mentioned in numerous DC manuscripts. Succeeded Thomas Alleyn as Master on 27/3/1631. Died 9/4/1642. According to his last Will dated 24/8/1641, he had a wife, Dorathie, a daughter, Anne (who married Robert Warner), a son, Matthias, and a son John (appointed executor). Brother-in-law of Richard Abbott.

**Alleyn, Thomas** : Alleyn’s brother

**Alleyn, Thomas** : Alleyn’s first cousin. A barber-surgeon and citizen of London. Appointed as first Master of DC on 13/9/1619. Died 27/3/1631.

**Alleyn, Thomas** : Alleyn’s first cousin once removed (son of John Alleyn); later (1631) Warden, then (in 1642) Master, of DC.

**Allin, Mr** : a worster (Worcester) man.

**Alline, ‘Ned’** : either Edward the son of Thomas Alleyn or Edward the son of Godfrey Alleyn, or, more likely, Edward Alleyn, the “poor fatherless child”, *q.v.*

**Altome, Mr** : Dined with Alleyn and others at the Red Cross on 30/10/1618.

**Andros or Androse, Doctor** : an alternative spelling of Lancelot Andrews, Bishop of Winchester.

**Angell, Thomas** : The Alleyns dined at The Dancing Bear on 6/5/1619 with Mr Angell, William Henslowe, and Jacob Meade. Also mentioned (as ‘Tho: Angell’) on 22/9/1619.

**Ann (of Denmark)**: Anne of Denmark (1574–1619), wife of King James I. Alleyn often performed for her at court, and his Diary notes her death (at 4.a.m on 1/3/1619) and funeral arrangements.

**Anthony, Mr Edward** : a clerk of the Privy Seal, to whom on 16/8/1618 Alleyn paid £8 “for my pattent”.

**Anthony, Jo. :** possibly John Anthony (1585–1655), physician. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Anthony, Margret :** a servant. Paid 5s wages on 24/12/1621. Formerly Margret Daggin?

**Archer, Mr :** possibly Robert Archer, gent., of St Saviour's, Southwark, mentioned in DC MSS 1, Article 25 dated 2/3/1599[1600]. Alleyn dined with Mr Austen, Mr Archer & Mr Owdse [?Olds] at The Cardinal's Hat on 12/12/1617.

**Argent, Doc :** John Argent, Fellow of the College of Physicians.

**Argent :** Lady Clark's servant, probably a reference to Dr Argent. Alleyn tipped him 2s 6d on 1/1/1617[18].

**Arundell or Arundle, Lord of :** Thomas Howard, fourteenth earl of Arundel, fourth earl of Surrey, and first earl of Norfolk (1585–1646), who was noted for his collection of antiquities, marble statues and paintings. Alleyn was personally shown his collection at Arundel House on 17/4/1618, and tipped his servant 2s. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619. He was briefly imprisoned in the Tower after a political quarrel at court and was visited there by Alleyn in May, 1621.

**Ashbye, William :** Alleyn's servant

**Attorney, Mr :** see Gravenor, Mr

**Austein or Austen, Mr and Mrs :** William Austen and his wife Anna. He was the son of Lady Joyce Clark and her first husband James Austen or Awsten, haberdasher, and served as a DC property co-trustee with William Alleyn. William (1582 to 1634) and Anna (d. 1624) are buried in Southwark Cathedral, formerly St Saviour's Church. William is mentioned in numerous DC manuscripts. Alleyn dined with Mr Austen, Mr Archer & Mr Owdse [?Olds] at The Cardinal's Hat on 12/12/1617, and had supper there with Mr Austen, bromefeeld, newman etc. on 17/12/1617. On 1/1/1617[18] Alleyn gave him 'a pair of silk stockings' and 'a pair of gloves', each costing £1 10s.

**Axell (Axel or Axen), Robert :** a member of the Queen's Company, 1631-33

**Axell, Mrs :** wife of Robert Axel

**Ayles, Black :** a servant. See Black Ayles.

B

**Bab, Mr :** an attorney.

**Backer, Doc :** a doctor at the Charter House consulted by Alleyn.

**Badins :** a labourer.

**Bager or Boger, John :** Alleyn paid Jo: bager 5s for 6 days' work on 25/11/1617, 3s for 4 days spent 'grubing in y<sup>e</sup> garden dich' on 29/11/1617, and 2s 4d for felling 14 trees in [the] 40 Acres [Coppice] for the under-construction ox house on 13/12/1617. At least three Dulwich residents/tenants called John Badger had been recorded since 1546, the first being a tailor, born c.1508. John Badger 'senior' died in 1618, when manor Aleconner. His son John Badger or Bodger (or his son of the same name) continued as a Dulwich tenant until 1647.

**Bager or Boger, Marie :** Marie Badger, probably the wife of John; they had a daughter named Sarah.

**Baldwin, Mr :** a cattle-dealer.

**Ball, Mr :** one of Prince Charles' musicians.

**Bannister, Mr :** a defendant in a lawsuit filed by Alleyn.

**Bannister, Sir Robert :**

**Baran or Baron :** a joiner employed by Alleyn in October 1617, on the first and third occasions with Baran junior.

**Barly, Mr :**

**Barratt, Widow or Goody :** either Margaret Barret, a 'poor sister' or almswoman, or more likely the widow of George Barrett, Dulwich labourer and resident from 1599 (when he was acquitted at Surrey Assizes of prophesying the death of the Queen within 3 years) to 1602. Widow Barrett was a tenant in her own right (at £2 p.a. for a house facing Dulwich Common) from 1628 (or earlier) to 1632.

**Bat or Batt, Robert :** a resident of Sydenham.

**Baway, Sir E. :** see Bowyer

**Baxter, Baxstere, Mr :** also referred to as Captain Baxter. Dined with Alleyn 9/11/1617, as did 'baxters man' on 7/12/1617. Too early to be Paul Baxter, not mentioned until 1631. Could be Robert Baxter, resident in 1620.

**Beale, Mr :** an attorney or scrivener, possibly the well-known scrivener Robert Bales.

**Beamond, Mr :** Richard Beamond, formerly gunner to the Queen, mentioned in Muniments 95 and 156.

**Beast :** see Best

**Beck :** 'beck:' dined with the Alleyns on 26/10/1617. Probably Thomas Beck or Abeck, son of Giles Abecke. Thomas was a Dulwich tenant of a house & 1 acre, probably fronting Dulwich Common, from 1602 (or earlier)

until his last mention (as Thomas Abecke senior) in December 1613. He (or his son of the same name) is mentioned as such on 18/4/1615, but not later.

**Beck, Bean or Bear:** Alleyn's workman.

**Beck, Goody :** probably the widow of Thomas Beck.

**Beck, Mr :** probably Thomas Beck.

**Belline, Mr :** a bailiff.

**Benfeild or Benfield, William :** a Southwark resident, and a Vestryman of the church of St Saviour's, Southwark. Alleyn attended his burial on 31/10/1619 (although according to the Church Register it took place on 20/10/1619).

**Bennett, Sir John :** Sir John Bennet (1552/3–1627), judge, Member of Parliament, fundraiser and overseer of building work for the Bodleian Library at the University of Oxford, and one of the first governors of Pembroke College, Oxford.

**Bennit, Ed :**

**Bess :** see Tylley, Bess

**Best, Mrs :** Wife (unnamed) of 'Old' Robert Best (q.v.).

**Best, Old :** Mentioned in DC MSS 5, ff. 2-6, and Muniment 570. Robert Best was a a Dulwich tenant (initially of Sir Francis Calton) from 1596, occupying 10 acres adj. his house and another 4 acres. On 11/9/1615 Alleyn leased him a house & 12 acres (in 4 closes) adj., and Butchers Close (8 acres), in Best's occupation. Last mentioned April 1620. No reliable record of birth, marriage, or death.

**Billson, Mr:** Leonard Billson, of Bishops Waltham, Southampton, was lessee of 'The James' or 'The Fool's Head' on the South Bank, who had assigned his lease (for 20 years at £4 p.a.) to Philip Henslowe in 1612. Alleyn continued until his death to pay Billson £1 a quarter (£2 5s on 1/1/1617[18]). Mentioned in DC MSS 540, ff. 115-18 and Muniment 53.

**Bin :** see Byne

**Bingham, Mr :** John Bingham, governor of St Saviour's Grammar School; mentioned in Muniment 164.

**Bir or Bird, Robert :** the actor Robert Bird.

**Bird, Will :** an actor in Pembroke's Men and the Admiral's, later Prince Henry's and Palsgrave's Men and joint-lessee of the Fortune Theatre; mentioned in DC 1, 25, 104, Muniments 56-58.

**Bishop of Winchester :** James Montagu (1568–1618), Bishop of Winchester from 1616 to 1618.

**Bishop of Winton :** see Bishop of Winchester.

**Black Ayles [Alice]** : presumably a ‘live-in’ servant (of African origin). Not a Dulwich tenant.

**Blincher or Blyncko, Mr** : possibly John Blencowe, citizen of London and a Southwark resident, whose son John (born 1609), became a playwright and Church of England clergyman.

**Blinckes, Mr** :

**Boane, Old Goody** : probably the wife (or more likely widow) of Walter Boane senior, or of Henry Bone (resident in 1590) or William Bone (resident 1586-1590). Dined with Alleyn on 2/11/1617.

**Boane, John** : see **Bone, John**.

**Boane, Watt**: Walter Boane, a ‘poor brother’ or almsman.

**Bodley, Sir John** : founder of the Bodleian Library, Oxford. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Bodman, Mr**:

**Boger, John**. See **Bager, John**

**Boger, Richard** : On 4/1/1617[18] ‘Rich: boger’ & his wife dined with the Alleyns.

**Boger, Robert** : On 1/1/1617[18] Alleyn received from Ro: boger a capon valued at 6d as a gift. On 4/1/1617[18] ‘Ro: boger’ & his wife dined with the Alleyns.

**Bogg, Sir James** : a poor knight to whom Alleyn gave money.

**Bone, John** : Jo: boane dined with the Alleyns on 19/10/1617. He sold Alleyn 2 bushels of oats for 2s 6d on 15/11/1617. On 1/1/1617[18] Alleyn received from Jo: boane a capon and a hen valued at 6d as a gift. On 4/1/1617[18] ‘John boan’ & his wife dined with the Alleyns. From 1597 Bone was lessee of Hall Place, with 45 acres, with woods & underwoods, at £20 p.a. for 21 years. Last mentioned 6/11/1618.

**Bonner, Mr** :

**Booth, Mr** : an associate of Sir Francis Calton.

**Borne** : see **Bird, William**.

**Borne, Will** : William Borne, a surgeon.

**Bough, George** :

**Bovir or Bovey, Mr** : Ralph Bovey, an attorney, mentioned in DC MSS 4 f. 137 and Muniment 552.

**Boweman, Mr** :

**Bowlton, Mr** : Thomas Bolton, a scrivener imprisoned in Marshalsea debtor’s prison who successfully sought financial relief from Alleyn, mentioned in DC MSS 3, Article 83

**Bowyar, Bowyer, Baway, Bowy, Sir Edmond :** of Camberwell, **sheriff of Surrey and Sussex, MP for Surrey, 1603; mentioned in numerous DC manuscripts.** Bowyer bought 5 houses & 3 acres on the north side of Dulwich Common in 1577, and sold them to Alleyn in 1609. The Bowyer family (much to Alleyn's annoyance) retained the advowson of Camberwell Parish church, hence Alleyn paying tithes for e.g. 3 acres in Annis field and a half acre in Dickariddings on 25/11/1617. On 4/1/1617[18] the Alleyns took communion at Camberwell '& S': Ed: bowyar dinde all our porre people'. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619. Died March 1626[27].

**Bradly, Mr :** Alleyn calls him a preacher; possibly Thomas Bradley (1599[1600]–1673), Church of England clergyman, who on 21 June 1620, became chaplain to George Villiers, Duke of Buckingham, with whom Alleyn had professional dealings.

**Brambeel, Mr :** a glassmaker.

**Brasier, Edward :** a 'Poor Scholar' at DC. Edward Braseer, son of Stephen Brasier, was baptised at St Giles, Camberwell, on 18th December 1605. 'Of Peckham' according to Ormiston. Admitted 6/9/1617. Provided with shoes until at least Oct. 1622.

**Bridgis or Brigges, Henry :** a 'poor brother'; possibly the Henry Bridges who was previously a Southwark resident.

**Brinchester, Brinkester, Brickester or Brink:** Thomas Brinkester, a 'poor scholar' at DC according to Prof. Ioppolo, but not according to Ormiston's Register. However, clearly resident at DC.

**Brograe, Mr :** an associate; possibly the son of Sir John Brograve (1538-1613), a prominent lawyer.

**Brograe, Mrs :** wife of Mr Brograe.

**Brom, Mr :** a horse-dealer.

**Brome, Mr :** George Brome, later clerk of DC, and noted in Munuments 56 and 594.

**Bromefield, Mr :** Robert Broomfield or Bromefeeld, **woodmonger of Southwark, mentioned in numerous DC documents,** and an acquaintance of the Alleyns since 1601 when he assigned to Alleyn a 1590 underlease for 26 years of a wharf in St Mary Overie, Southwark. Had supper with Alleyn at The Cardinal's Hat on 17/12/1617.

**Bromley or Bromiley, Baron :** Sir Edward Bromley (1563-1626), a judge, who was appointed a serjeant-at-laws and a baron of the Exchequer in 1610

**Brooks, Mr :** a cattle drover

**Brosone, Mr :**



**Brounrigge, Robert.** Son of Thomas Brownerigge (buried 30/5/1626). Baptised at St Botolph's Bishopsgate on 7/11/1613. Admitted as a Poor Scholar 31/3/1622. (Recorded in Ormiston's Register, and by Prof. Ioppolo, as 'Brouning', but by Alleyn as 'Brounrig'.)

**Brown or Browne, Mr :** a resident of Lewisham.

**Browne, Mrs :**

**Buckett, Mr :** a craftsman who 'limned' a silver book given by Alleyn to Lady Clarke on 31/12/1617; possibly the Rowland Buckett who was a Southwark resident.

**Buckingham, Markques of :** George Villiers (1592–1628), first duke of Buckingham, and courtier to King James I. Villiers was particularly known as a collector of art, a hobby Alleyn shared on a lesser level.

**Buckingham, Countess of :** Lady Katherine Manners (1603-1649), married George Villiers in 1620, subsequently becoming the Countess of Buckingham.

**Budder, Owld :** an elderly man.

**Burnett, Mr :** possibly an alternate name for Mr Burrett.

**Burrell, Mr :** 'preacher'; possibly Robert Burhill or Burrell (?1572-?1641), Church of England clergyman. Dined with the Alleyns 30/11/1617.

**Burrett or Burett, Mr :** an organ repairer

**Burward, Mr :** an organ tuner.

**Butterfeeld, Thomas :** a weaver from Iver in Buckinghamshire, mentioned in Muniment 421.

**Bygroue, see Brograue**

**Byne, Lady :** wife of Sir John Byne or Bynd, and niece of Sir Edmond Bowyer.

## C

**Caldham :** Richard Caldham or Caulham, a 'boarder' (rather than a 'Poor Scholar', according to Ormiston) at DC, admitted 29/12/1620. Left 24/3/1621.

**Callton, Calte, Calton, Caltone, Sir Francis :** Sir Francis Calton, from whom Alleyn purchased the manor of Dulwich and with whom Alleyn continued to have disputes over property; mentioned in numerous DC manuscripts

**Caltone, Duke :** son of Sir Francis Calton. Baptised 14/11/1602.

**Callvert, Sir George :** George Calvert (1579/80–1632), a courtier appointed by James I as a clerk of the Council Privy in 1610 and in 1619 as

secretary of state and as a Privy Councillor. He was made first Lord Baltimore in 1624.

**Calvert, Sam:**

**Canterburie, John :** With Ralph Canterbury (q.v.) and nine others helped with Alleyn's harvest in September 1621. Possibly the John Canterbury baptised at SS Peter & Paul Church Mitcham on 25/9/1595, although he was stated to be the son of Richard Canterbury.

**Canterburie, Lord of:** George Abbot, Archbishop of Canterbury 1611-33, who had led the service of con-secration of the College Chapel on 1st September 1616. In 1621, he received a formal pardon from the king for accidentally shooting and killing a gamekeeper. Abbott dined with Alleyn 14 months after this incident.

**Canterburie, Ralph :** a wheelwright and general carpenter/joiner, mentioned in Muniment 578 as lessee of a house & 5½ acres, part of Cockmans, for 31 years at £3 13s 4d p.a., granted on 17/10/1628. No traceable record of his birth, marriage, or death, or that of his unnamed wife, with whom he had a son and daughter. Employed by Alleyn for various items of woodwork, and on 25/10 1617 for threshing wheat for seed. He and his wife dined with the Alleyns on 19/10/1617. Alleyn paid him 11s on 3/1/1617[18] for 'cleaving 3 Lod of Logges' and other tasks relating to a plough. Last mentioned 30/4/1622.

**Canterburie, Mrs :** wife of Ralph, also a labourer.

**Carman, Grigorye (Gregory) :** a labourer.

**Caron, Carone or Corone, Lord :** Noël de Caron (c1530-1624), diplomat who served both under Queen Elizabeth I and King James I, and formally appointed in 1609 as Ambassador to Holland of the '3 general states'; mentioned in DC MSS 3, Article 58. Like Alleyn, he collected art.

**Carry, Lord :** Sir Richard Carew (1579/80–1643?), first baronet, known for his medical experiments and his work in reforming education. He was the eldest surviving son of the poet and antiquary Richard Carew (1566-1620).

**Carsey :** see Kersey.

**Cartwright, Mr :** William Cartwright the elder, actor in the Admiral's, later Prince Henry's and Palgrave's Men. He was an investor in some of Alleyn's businesses and is mentioned in numerous DC manuscripts; he was the father of the actor and bibliophile William Cartwright the younger (1606-1686) who bequeathed books and actors' portraits to DC at his death. 'Cartwright gannell & parr', all members of the Fortune company, dined with the Alleyns on 22/3/1617[18].

**Carue, Sir Matthew** : **civil lawyer** born 1531, and a Master in Chancery until his death in late July 1618.

**Caryes, Sir Nicholas** :

**Casen, Mr** : **a local councillor.**

**Casinghurst, Beathie** : Alleyn's servant. Probably Bathsheba, daughter of John Casinghurst. Later a Dulwich tenant.

**Casinghurst, John** : Alleyn's tenant : On 27/12/1617 'Casing Hurst' sent 2 rabbits (for which Alleyn paid him 6d). The following day Jo: Casinghurst and his wife dined with the Alleyns.

**Casinghurst, Kester** : Kester Casinghurst dined with the Alleyns on 5/10/1617. ?= Christopher Casinghurst, a Dulwich resident since 1584, when he was aged at least 12. Headborough for Dulwich manor at the time of his death in March/April 1618. Christopher Casinghurst, servant to Mr Thomas Cooper, Preacher in Whitecross Street (where the Fortune Theatre was), who must be the same person, was buried on 2 April 1618.

**Caulden** : See **Caldham** :

**Celeys, Mr** : **a haberdasher.**

**Cesel, Coronell** (i.e. Colonel) : **Sir Edward Cecil (1572–1638), Viscount Wimbledon, soldier and politician and later Lord Cecil; son of Thomas, Earl of Exeter and grandson of William Cecil, Lord Burghley.** Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Chalfont, Richard** : **a 'poor scholar' at DC.** Richard, son of --- Chalfont, of St Giles, Cripplegate. Admitted 6/9/1617. Provided with shoes until at least Oct. 1622.

**Champion, Mr** : **Alleyn's tenant.**

**Chancellor, Lord** : **Sir Francis Bacon (1561-1626), Viscount St Alban (i.e., Lord Verulam), Lord Chancellor, politician, author and philosopher.** As Chancellor he attempted to block Alleyn from gaining permission to establish DC as a charitable foundation but eventually relented. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Cheek, Mr** : **a lawyer**

**Chester, Mr** :

**Ciecell.** See **Cesel.**

**Clapham, Mrs** : **probably Margaret Chapman, a 'poor sister' or almswoman.**

**Clark, Lady** : **Joyce, Lady Clark, Alleyn's patron and the widow of Sir Robert Clark, a Baron of the Exchequer, who died in 1607; her previous**

husband was James Austen, or Austein, who died in 1602. Lady Clark, who is mentioned in several DC manuscripts, died in 1626 and is buried in Southwark Cathedral, formerly St Saviour's Church. She was the mother of William Austen (q.v.), Alleyn's friend and confidant. Alleyn visited her on 29/9/1617, 28/10/1617 (when he paid 6d for wine), 5/11/1617 (1s), 18/11/1617 (1s at supper) and 19/11/1617 (6d at dinner). On 31/12/1617 he gave her 'my silver booke', with verses (which cost him 10s) written in it, and on 1/1/1617[18] he gave her 'a pair of silk stocks' costing £1 10s. According to gratuities paid to her establishment on 1/1/1617[18], she had a staff of nine, including a coachman and 3 maids.

**Claye, Goodman :** a labourer.

**Coal or Coles, Mr :** possibly Roger Cole of St Saviour's, Southwark or George Cole; both are mentioned in DC manuscripts.

**Coates, Mr :** Alleyn bought a mare from him for £2 4s on 15/11/1617.

**Cofferer** see Ingrome, Sir Arthur

**Colbrand or Collborne, Mr :** John Colborne, a 'poor brother' or almsman.

**Collgatt, Mr :** sold seeds to Alleyn.

**Collins :** Edward Collins, a 'poor scholar' at DC. Admitted 11/3/1617[18]. Provided with shoes until at least 27/7/1622.

**Collins, Henry:** a servant; probably the Henry Collins who was resident in Southwark.

**Collins, Mrs :** one of the tenants of the Blackfriars.

**Collins, Ned :** cousin of Charles Massey; probably the Edward Collins who was a Southwark resident.

**Collman, Mr :**

**Cooke, Mr :** A preacher, who preached at DC on 14/12/1617.

**Cooke or Cock, Will :** William Cook, a labourer; eventually sacked for theft.

**Cooper, Mr :** probably Robert Cooper, a London skinner, and one of Alleyn's tenants (of a house 28 acres, including Addingtons Meads), mentioned in Muniments 571. On 1/1/1617[18] Alleyn received from 'M<sup>r</sup> Cooper' 9 cakes, valued at 3d, as a gift. On 4/1/1617[18] Mr Cooper & his wife dined with the Alleyns.

**Copherer** see Ingram, Sir Arthur

**Copland, John :** a 'poor scholar' at DC. John, son of John Copland, 'Cooke', baptised at St Giles, Cripplegate, on 3rd December 1609. Admitted 6/9/1617. Provided with shoes until at least Oct. 1622.

**Cople :** a craftsman.

**Copline, Mr :** probably an almsman.

**Corden William** : mentioned in DC MSS 3, Article 71.

**Cotton, Mr** : probably Allan Cotton (d. 1628), one of two appointed Sheriffs of London, and Master of the Draper's Company, from 1616-18

**Countess of Kildare** : Frances Howard (d. 1628), daughter of Charles Howard, Earl of Nottingham, to whose company of players Alleyn once belonged. Widow of Henry Fitzgerald, Earl of Kildare and of Henry Brooke, Lord Cobham, who was implicated in the conspiracy of Walter Raleigh against James I.

**Cowden, Mr** :

**Crane, Mr** : a preacher.

**Cranvell or Cranwell, Mr** : probably Thomas Cranwell, a labourer and Alleyn's tenant; mentioned in MSS 6, Article 24.

**Crewe, Sir R.** : Sir Ranulph, Randolph, or Randall Crew or Crewe (1559-1646), sergeant-at-law and a judge. Usually referred to by Alleyn as S<sup>r</sup> Randall or Randelle Crewe. Involved in William Henslowe's suit in 1617.

**Croft, Mr** : probably Thomas Croft, mentioned in Muniments 32-342.

**Crosts, Mr** : a leather dealer.

**Cullen, Mr** : Edward Cullen, a 'poor brother', or almsman, recommended by Stephen Gosson; mentioned in DC MSS 3, Article 78.

**Cullis** :

**Cunstable of Eltham** :

**Cure, Mr** :

**Cutler or Cuttler, Bess or Elizabeth**:

**Cuxson or Coxson** : Probably Thomas Coxson, a property-owning 'white baker' of Golding Lane, St Giles-without-Cripplegate, living in the parish of St Botolph's-without-Aldgate at his death c.1618. His widow Marie, who moved to Eltham, married (on 4/2/1624) a Richard Garford. The reason for the annuity paid to them quarterly by Alleyn of £30 p.a. is unknown, but must have some connection to the Fortune Theatre, in or to the east of Golding Lane.

**Daggett** : Alleyn paid 'daggett that bid me to Lo: wm [the Lord Mayor, Sir William Cokayne]' 1s on 24/12/1617.

**Dagine or Daygine, Margaret** : a servant.

**Daggin, Dagine or Daygine, Richard** : a servant.

**Dallen, Mr** :

**Daling, Bayly** : i.e. Bailiff Dailing.

**Daly or Dawly, Mr** :

**Daniell, Mr** : a Scotsman to whom Alleyn gave money  
**Danson, Dansone or Daunsone, Peter** : one of Alleyn's landlords

**Davies, Goody** : possibly the Agnes Davis who was resident in Southwark, or possibly the widow of Phillip Davise, listed as one of ten 'billmen of y<sup>e</sup> second sort' for Dulwich in c.1570. On 27/12/1617 'goody davis' brought Alleyn 'a Coller off brawn', , and on 1/1/1617[18] Alleyn received from 'davis' 'a collar of brawne' [?the same one] as a gift.

**Davison, Mr** :

**Deane off Pawls** : i.e. John Donne; see Done

**Delluer (i.e. Dellver), Mr** : a seed-dealer.

**Demayn, Charles** :

**Dennis, Thomas** : an animal dealer.

**Dennis, Mr** : an associate.

**Diciling** : Robert Diciling, Dicylyng, or Disiling, a Poor Scholar. Of Bishopsgate. Admitted 17/3/1621[22]. Provided with shoes until at least Oct. 1622.

**Dick** see Double, Dick

**Dickenson** : a clothier.

**Dickinson, Goody** :

**Dobsone, Sarah** : a maid.

**Dole, Doll or Dolle** : Alleyn's relative, or at least close friend. Evidently lived in or around London north of the Thames, and married on 7th June 1618, which limits the possibilities (if 'Doll' was female) to widow Heaster Cockes (who married a David Chin, Glum, or Olum in Coleman Street), Mary Brooke (who married Thomas Hardinge at St Dunstan in the East), Joane Clarke (who married Robert Davies at St Margaret's Westminster), or – most likely – Sara Davies (who married Hugh Browne at St Giles Cripplegate).

**Done or Dun, Doc** : Dr John Donne (1572–1631), poet, and Church of England clergyman, and Dean of St Paul's from November 1621, mentioned in numerous DC manuscripts. His daughter Constance, who became Alleyn's wife, is listed as 'y<sup>e</sup> dean off pales dafter'.

**Dorington, Mr** : probably Sir John Dorrington, Master of the Royal Game of Bears, Bulls and Dogs, with whom Alleyn was involved in lawsuits; mentioned in numerous DC manuscripts

**Double or Duble, Dick** : a servant.

**Doughton, Mr** : Thomas Downton or Downton, a member of the Lord Admiral's Men and later the manager of Prince Henry's Men

**Drewe, Mr :** named by Alleyn as one of Prince Charles I's musicians; probably Thomas Drew, an actor in Queen Anne's Men until 1619.

**Drews :**

**Driting, Robert :** a 'poor scholar' at DC.

**Drolt, Mr :** a tiler and plasterer.

**Ducsome, Mr :**

**Dune** see **Done**

**Dutton, Ned :** possibly Edward Dutton, a Southwark resident.

**Dwitt, Mr :** Almost certainly either John Dewytt, son of a 'Bardgeman', Thomas Dewytt, baptised at St Saviour's, Southwark, on 19/11/1598, or (more likely) Thomas himself. 'dwitt' was paid 4s on 19/11/1617 for 'spreding ye denshird Hills', and he and his wife dined with Alleyn on 28/12/1617. Thomas Dewett died 'at ye Oxe stalles' in Deptford in January 1640[41].

**Dwss, Mr :** possibly a misspelling of Dwitt

E

**Edmonds, Mr :** John Edmonds, an actor in the Queen's Men.

**Edmonds, Sir Thomas :** Treasurer of the King's Household, 1618-1639.

**Ellary, Mr :**

**Ellice, Thomas :** one of Alleyn's servants.

**Ellice, Thomas :** a tailor or clothier, probably a Southwark resident

**Ellice, Mrs :** a labourer

**Emeson, Mr and Mrs :** labourers.

**Ewins (or Ewine, Erwine), John:** Father of Elizabeth Ewen. Alleyn paid him, on her behalf, £1 p.a. for a small parcel in Napps, the ownership of which had been disputed between them.

**Etherick, Mr :**

**Euans, Mr :** a labourer

F

**Faussett, Mr :**

**Feeld or Field, Goody :** Possibly widow of Nicholas Field (Dulwich resident in 1599). Dined with Alleyn 2/11/1617.

**Feeld, Matthew :** probably the Matthew Field who had been a Southwark resident

**Ferrers, Ferres, or Ferris, Mr :** Edward Ferrers, with whom Alleyn had a legal dispute; mentioned in DC MSS 3, Article 82. Alleyn dined with 'ferris & w: H:' at 'ye bear' on 1/11/1617.

**Finch, Erasmus :** involved in a legal dispute with Alleyn.

**Finch, John, Sergeant :** counsellor; possibly the John Finch who became Baron Finch of Fordwich (1584–1660), a speaker of the House of Commons and a judge. “Jo: finch Councillor” witnessed the Foundation Deed and was one of the guests at the Foundation Dinner on 13/9/1619.

**Fleming, Mr :** a labourer.

**Flower, Franc :** Francis Flower, a stonecutter.

**Flud or Fludd, Dr :** Robert Fludd (1574-1637), physician and writer on the occult, whose works included *Utriusque cosmi* in two volumes (1617–21), and the *Medicina catholica* in four parts (1629–31).

**Ford, Mr :** a witness in a legal case in which Alleyn was involved.

**Foster, Alec :** probably Alexander Foster, an actor in the Lady Elizabeth’s Men mentioned in 18, Article 9 and Muniments 47.

**Foster, Goody :** Alice Foster, a ‘poor sister’ or almswomen from St Giles, Cripplegate. Alleyn paid 4s 9d on 4/4/1618 for her ‘things’, following her death.

**Fouks, Jo :**

**Fowler, Sir Edmund :**

**Fowles or Fowls, Mr :**

**Fox, Favor :** a labourer.

**Francis :** On 1/1/1617[18] Alleyn received from ‘francis’ a pullet, as a gift.

**French, Mr :** a tradesman.

**‘Frez’ :** a woman who paid Alleyn rent equivalent to £386 12s a year (£29 14s 9d for four weeks), but for what is unclear. On 17/11/1617 she paid £1 ‘for last month & oweth a fortnight’. On 21/12/1617 Alleyn received 20s from ‘frez’, leaving her owing for two weeks. Possibly ‘Frez’ (clearly a pet-name) was in charge of some of the ‘ladies of negotiable virtue’ (or ‘Winchester geese’) in the Liberty of the Clink from whom Alleyn allegedly derived an income.

**Frithe, Mr :** Wiliam Frith, a haberdasher; mentioned in DC MSS 4, Article 38 and Muniment 118.

**Furlonge, Mr :**

**Futtrell, Edward :** a servant.

**Fyllcocks, Goody :**

G

**Galyardo or Gallyard, Mr Ceaser :** Caesar Galliardello (1568-1627), musician, one of the King’s musicians; he apparently recommended Benjamin Cosyn to Alleyn as organist of DC in 1622.



**Gannell, Richard** : see **Gunnell, Richard**

**Gardiner, Mr** : a labourer.

**Gardner, Sir Thomas** : a barrister; mentioned in Muniments 176 and 177, and a Southwark resident.

**Garman, Mr** : an actor in the Fortune acting company.

**Garrell** : Alleyn's tenant. See **Quarrell**

**Garrett, Nic** :

**Garrett, Thomas** : a Southwark resident.

**Genings [i.e. Jennings], Mr** : a Camberwell churchwarden.

**George or Gorge** :

**Gerratt, Mr** : possibly John Gerratt, a clothworker; mentioned in DC MSS 1, Article 55 and Muniment 36, or more likely Master Gerratt, a lawyer representing William Henslowe in 1617. Alleyn paid Mr Geratt a fee of £1 2s on 6/12/1617 'to get my Evidence out of Chauncerie', but deleted the entry. He paid his fee of £1 2s on 17/12/1617 'for a motion for this order' (i.e. to fetch Alleyn's 'Evidences' from Chancery), and on 20/12/1617 for Gerratt's 'Hand to my asnwer' and 'for his motion at the next Seal' another £1 2s, twice. He repeated the 'fee for a motion of £1 2s on 24/12/1617, but again deleted it.

**Gibbkin, Mr** : a picture dealer.

**Gibbs, Mr** : organ dealer.

**Gifford, Mr** : a fellow of DC. Revd. John Gifford, appointed First Fellow (Preacher) on 24/12/1620. Left 28/9/1623.

**Gillpine, Mr** : the mace-bearer for Archbishop George **Abbott** or **Abbot**, q.v.

**Glacock or Glasscock, Baley** : a local bailiff.

**Godman** :

**Gondomarr, Archibishop** : Diego Sarmiento d'Acunha, Conde de Gondomar, The Spanish Ambassador and later a satiric subject of Middleton's *A Game at Chess*.

**Goodlack, Mr** : Alleyn's associate.

**Googe, Mr** : Barnabe Googe (1540–1594), poet and translator; author of *The Whole Art and Trade of Husbandry* (published in 1614)

**Grace, Francis** : an actor in Prince Henry's, later Palsgrave's Men and joint-lessee in the Fortune Theatre; mentioned in Muniments 56-57; probably the Grace mentioned as Alleyn's tenant in Golding Lane, London, on repairing whose house Alleyn spent 12s 8d on 30/1/1617[18].

**Gravenor, Mr** : Alleyn's attorney.

**Graye, Mr :**

**Green, Mr :** a defendant in one of Alleyn's lawsuits

**Green, Robert :** Lady Clark's servant. Alleyn tipped him 2s 6d on 1/1/1617[18].

**Gregory, Mr :** Alleyn's barber.

**Gressame :** a scrivener.

**Griffen, Dick :** a Southwark resident

**Griffin, Christopher :** a Southwark resident. Admitted (?as a boarder rather than as a Poor Scholar) to DC on 31/3/1621.

**Griffin, Rowland :** a servant

**Griffine, Mr :** probably John Griffin, a tenant or landlord of Philip Henslowe; mentioned in DC MSS 5, Article 25

**Grimes.** See Grymes.

**Gritton, Mr :** a servant. Alleyn paid 'gritton' for making a back in the kitchen chimney on 1/11/1617, and 1s for mending the churchyard wall coping on 25/11/1617, suggesting that Gritton was a builder rather than a servant. On 28/12/1617 'gritton' and his wife dined with the Alleyns.

**Gritton, Widow :**

**Grymes or Grimes, Sir Thomas :** mentioned in numerous DC manuscripts. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Goarg (George) :** Alleyn's servant; probably George Quarrell (q.v.).

**Gosens, Mr :** a goldsmith.

**Gullson or Gulston, Dr. :** Theodore Goulston (1575-1632), a prominent physician and member of the College of Physicians, who on 13 March 1618 examined Alleyn's urine (or 'water') in order to diagnose an illness

**Gunnell, Richard :** Richard Gunnell (d. 1634), actor, manager and dramatist in Prince Henry's, later Palsgrave's, Men, and joint-lessee of the Fortune Theatre; mentioned in DC MSS 1, Article 115, Muniments 56-57 and 67-69 and Second Series MSS 100.8. 'Cartwright gannell & parr', all members of the Fortune company, dined with the Alleyns on 22/3/1617[18].

**Gunnell, Mrs :** wife of Richard Gunnell.

**Gwalter, Mr :** William Gwalter, innholder and joint-lessee of the Fortune Theatre; mentioned in Muniments 60 and 61

H

**H:** see **Hid.** (Also an abbreviation for 'Half'.)

**H., Jo. :** John Henslowe, q.v.

**H., W. :** William Henslowe, *q.v.*

**Had or Haddon, Tom :**

**Hallsey, Mr :**

**Hamden, Mr :** *an organ repairer.*

**Hammon or Hammond, Thomas :** Two people. The elder (?baptised in Lambeth in December 1582) was occupier of Butchers Field in 1604, and lessee of Great Brownings (7 acres) and Perifield (12 acres) from 1606. The younger, son of Thomas Hamond, was baptised in Camberwell in November 1597[!]. On 8/11/1617 Alleyn paid 'Hamon' a total of £2 7s 3d on 8/11/1617 for mowing 18½ acres in Crouchmans, Annisfields, the two Rigates and The Pitts, mowing oats, mowing in Hamons Coppice, cutting peas, and 14 days threshing tare wheat in Little Rigate. On 26/12/1617 'Hamond & His (unnamed) wyfe' dined with the Alleyns. On 1/1/1617[18] Alleyn received from 'Hamon' a pullet valued at 6d as a gift. On 4/1/1617[18] 'Hamon' & his wife dined with the Alleyns.

**Hamon, Hamond, Tho. :** *a thatcher.*

**Hanford, Mr and Mrs :** *probably John Hanford and his wife, Alleyn's tenants*

**Harie :** Alleyn recorded on 6/12/1617 that 'another man Harie [Harry] is here'.

**Haris or Harris, Mr :** On 19/10/1617 'Mr: Haris & His frend' dined with the Alleyns. Might be Anthony Harries (served on the manor jury in 1611), but more likely John Harryes Esq., *q.v.*

**Harison :** a carpenter/joiner/handyman. On 6/12/1617 Alleyn paid Harison's bill of £2 17s 5d 'for all waynskottes & other stuff'. Harison's unnamed son assisted.

**Harris, Bess :** *a Southwark resident.*

**Harris or Harriz, Mr :** *Alleyn's tenant.*

**Harrison, Mr :** *a shoemaker; probably Nicholas Harrison, listed as a haberdasher in DC MSS 4, Articles 17 and 22.*

**Harrison, Harisone, Rev. John, MA :** *mentioned in numerous DC manuscripts.* On 20/12/1617 Alleyn wrote '...now Mr Harrison is Here'. Third (Usher) Fellow appointed 20/12/1617, promoted to Second (Schoolmaster) Fellow 29/9/1618. Left 28/9/1620, having secretly married Alleyn's cousin's daughter Anne ('Nan') Alleyn, whom Alleyn employed as a servant until she left on 3/10/1620.

**Harryes, Mr :** On 19/10/1617 'Mr: Haris & His frend' dined with the Alleyns. John Harryes Esq. was Alleyn's Steward of Dulwich manor from 1606 to 1622.

**Hart, Mr :** probably a scrivener or alderman.

**Hart :** On 18/11/1617 Alleyn had dinner (for 1s) at ‘hartes ordinarie’. An ‘ordinary’ was a tavern offering food, drink, and accommodation.

**Hartridge or Hartredg, Mr :**

**Harvey, Doctor :** Dr William Harvey, fellow of the College of Physicians.

**Harvie, Bess :** a servant.

**Havall, Mrs :**

**Havas, Mr :** a tailor.

**Hayne or Haynes, Walter or Watt :** Not a Dulwich tenant; presumably a ‘live-in’ servant. Alleyn paid ‘Haynes’ 10s ‘for hewing 5 load of tymber’ on 20/12/1617, and on the same day paid 4d for ‘Watt Haynes affidavitt’. On 27/12/1617 Alleyn paid ‘Haynes’ £1 more ‘for y<sup>e</sup> oxen Howse’, making £5 in all.

**Hed, Sir John :**

**Hench, Morgane :** a labourer.

**Henslowe, John :** son and heir of Edmond, the elder brother and heir of Philip Henslowe who sued Alleyn over Henslowe’s will; mentioned in numerous DC manuscripts. Buried (as John Henslowe) at St Saviour’s, Southwark, on 11/9/1617. Alleyn paid 2s 4d on 1/1/1617[18] for an affidavit of his death.

**Henslowe, William** (also called ‘w: H:’) : Philip Henslowe’s brother, with whom Alleyn was in protracted litigation concerning the Bear Garden (which Alleyn won) and Philip Henslowe’s will; mentioned in numerous DC manuscripts.

**Hern, Herne or Hearne, Benjamin :** a servant.

**Hethersall, Walter :** Probably son of George Hethersall of Mitcham (died January 1616), whose 1606 lease (from Thomas Calton) of a house & 3 or 4 acres, Norcrofts (16 acres), Great Bornes (12 acres) was assigned to Alleyn, but which Walter Hethersall (first mentioned in 1600, last mentioned 1638) still occupied with Little Brownings, Carters Garden, & Carters Hall (8 acres in all). On 26/12/1617 Hethersall & his [unnamed] wife dined with the Alleyns. On 1/1/1617[18] Alleyn received from ‘Hethersall’ a hen valued at 6d as a gift. On 4/1/1617[18] Hethersall & his wife dined with the Alleyns.

**Hewitt or Huitt or Hwitt, Mr :**

**Hichinson, Lenerd :** Although clearly known to Alleyn, ‘Lenerd Hichinson’ has not been identified.

**Hicks, Mr :** probably a moneylender.

**Hid, Hidth or Hyd, Mr :** a defendant in a Court of Requests lawsuit by Alleyn

**Hieth, Ja. :**

**Hills, Mr :**

**Hillyard, Mr :** Possibly the great miniaturist painter Nicholas Hilliard (1547-1619), but more likely Edward Hilliard, a London Imbroiderer, who dined with the Alleyns on 25/10/1618 to celebrate their wedding anniversary.

**Hince or Hench, Morgaine :** a labourer.

**Hind or Hinds :** Alleyn paid 5d 'for Hinds shoes' on 11/12/1617. Possibly 'Heinz'? Not a Poor Scholar.

**Hitchcock, Mr :**

**Hobbs, Mr :** probably Thomas Hobbs, an actor in the Duke of York's, Prince Charles's Men and King's Men, mentioned in DC MSS 1, Article 107.

**Hobdaye, Jo. :** John Hobdaye, a business associate; mentioned in DC MSS 18, Article 12.

**Hodskins or Hogskins, Dr. :**

**Hoell or Howell Mr :** a labourer.

**Holby, Mr :**

**Holman, Mr :** a clerk.

**Hook, W. :**

**Hookes, Elizabeth :**

**Hope :** Although clearly known to Alleyn, 'Hope' has not been identified.

**Hopkins, John :**

**Hopkins, Thomas :** Organist and fellow of DC, probably previously resident in Southwark. Thomas Hopkins was Fourth Fellow (Organist) appointed 26/3/1618. Left 28/9/1622.

**Hopkins, Thomas :** possibly the Thomas Hopkins, yeoman of Newington, Surrey, mentioned in DC Muniments 449 and 469.

**Horne, Mr :** probably William Horne, a grocer; mentioned in DC Muniments 98.

**Howard, Thomas, 14th Earl of Arundel :** see Arundell

**Howland, Sir John :** High Sheriff of the County of Surrey. Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Huckle, Yeoman :**

**Hudson, Chancellor :** a Chancellor in the Court of Requests.

**Hudsone, Mr :** Alleyn's tenant; possibly Ralph Hudson, mentioned in Muniment 97.

**Hudsone, Widow :** widow of Mr Hudsone.

**Hugh** see Vnderwood, Hugh

**Hunt, Mr :** probably Thomas Hunt, the actor in the Admiral's and Lady Elizabeth's Men, mentioned in Muniment 47 and DC MSS 18, Article 9.

**Hurst, Casing :** see Casinghurst

**Hussey, Doctor :** possibly the Dr Robert Hussey who was a Southwark resident, or more likely a lawyer ('Mr: doc: Hussey') in Doctors Commons to whom Alleyn paid (2s) for a warrant on 28/10/1617.

**Hym :**

**Ingram, Mr :** a neighbour who bought Alleyn's mare; probably the Thomas Ingham mentioned in Muniment 247.

**Ingrame, Sir Arthur :** Sir Arthur Ingram (c1571-1642), financier and politician; Cofferer of the King's Household, 1615-1620.

## J

**Jacka, Jackar, Jackey, Jackay (or Jack), Christopher ('Kit'):** Christopher Jacka, a 'poor scholar' at DC. Christofer, son of a Waterman, Robert Jack, was baptised at St Saviour's, Southwark, on 11th July 1605. Admitted 6/9/1617. Left before 30/3/1622.

**Jackson, Sir John :** an official in the Office of the Exchequer.

**Jacob :** see Meade, Jacob

**Jacson :** a blacksmith/ironmonger, employed at DC by Alleyn on several occasions. On 5/1/1617[18] he paid Jackson £21 10s 6d to cover four of his smithying bills, including 5s 10d for 'drenching & Letting bludd of oxen'.

**James, Aunt :**

**Janikin, Mr and Mrs :**

**Jaxson or Jackson, Mr :** Possibly a lawyer. Alleyn had dinner with 'y<sup>e</sup>[sic] Jaxson' at the Clink on 14/10/1617.

**Jeffe or Jeffes, Mr :** Anthony Jeffs, an actor in the Lord Admiral's, later the Prince of Wales's Men; mentioned in DC MSS 1, Article 67 and Muniment 176.

**Jeremy, Sir** see Turner, Sir Jerimy

**Joice or Joyce, Robert :** Not recorded as a Dulwich resident. Dined with the Alleyns on 19/10/1617.

**Joas, Mr :** a tenant.

**Jobe or Jobye, Mrs :**

**Joce, Mrs :** probably the wife of Robert Joace or Joyce.

**John :** a labourer.

**Johnson, Shreue :** Robert Johnson, one of two appointed Sheriffs of London from 1617-18

**Jones :** probably John Jones, a ‘poor brother’, or almsman, mentioned in DC MSS 3, Article 67.

**Jones, Goody or Widow :** Goody Jones dined with Alleyn 23/11/1617. On 1/1/1617[18] Alleyn received from her eggs and apples valued at 4d as a gift. Goody Jones or Widow Jones was a Dulwich tenant (of 2a.1r.0p. in Napps) until 29/9/1627. No reliable record of her death.

**Jones, Inigo :** Inigo Jones (1573–1652), architect, theatre designer, the King’s Surveyor. Witnessed the Foundation Deed and one of the guests at the Foundation Dinner on 13/9/1619.

**Jones, Richard :** possibly the Richard Jones (fl. 1564–1613), bookseller and printer. Witnessed the Foundation Deed and one of the guests at the Foundation Dinner on 13/9/1619.

**Jones, Mr :** a shoemaker/mender.

**Jones, Mr :** Alleyn’s drinking companion and employee of Mr Cartwright

**Juby, Mr :** Edward Juby, actor in the Admiral’s, later the Prince of Wales and Palsgrave’s Men and joint-lessee of the Fortune Theatre; mentioned in DC MSS 1, Article 67, Muniments 56-57 and 499, and Second Series MSS 100.12.

**Jucke :**

**Jugg :** ‘Jugg’ was a pet-name for Joan, daughter of Thomas Alleyn.

**Juggs :**

K

**Kayes. See Keyes :**

**Kemssalle or Kempsale, Mr :** a labourer. On 28/12/1617 ‘kemsalle’ and his wife dined with the Alleyns. No known Dulwich resident at the time, but John Kemsall was resident 1559-1562, Mathewe Kempssall in 1588, and Richard Kempssall from 1632 to 1645.

**Kempssall, Goody :** a labourer and wife of Mr Kempssalle.

**Kersey, Mr :**

**Kester, Mr :** a blacksmith. ‘Kester’ [?Casinghurst, *q.v.*] dined with Alleyn on 2/11/1617.

**Keyes, Thomas :** a poor scholar at DC. Of Southwark. Admitted 6/9/1617. Provided with shoes until at least Oct. 1622. *‘Was sent to Cambridge’*, according to Ormiston.

**Kichin, Mr.** Anthony Kitchen, a Dulwich tenant. No official record of his own death or burial (recorded by Alleyn) in Camberwell in December 1618, but ‘Anthonie Kitchen a childe’ was buried at St Saviour’s, Southwark, on 16th January 1613[14].

**Kichin, Mrs.** Wife of Anthony Kichin or Kitchen. First name unrecorded.

**Kichin :** possibly the son of Anthony Kitchen.

**Kingsland, Arthur :** Dulwich resident since 1604. Dined with Alleyn 22/11/1617. On 1/1/1617[18] Alleyn received from ‘Ar: kingsland’ a hen valued at 6d as a gift. On 4/1/1617[18] ‘Ar: Kingsland’ & his wife dined with the Alleyns. Died March 1619. His widow, Dorothy, married Walter

**Bone** (q.v.) 7/2/1619[20]).

**Kingsland, Widow :**

**Kingston** see **Kingsland**

**Kiping or Kipping, Edward :** a labourer. Edward Kipping was a Dulwich resident from 1602. From 1625 occupied The Old Blew House as an unlicensed ‘victualling house’. Married, with a son and daughter who both died soon after birth in July 1622. Last mentioned April 1629. On 18/10/1617 would have been paid 6s for grubbing 14 rods (77ft) of Hamons [Coppice], but the entry was deleted.

**Kiping, Mrs :** a labourer.

**Kipitt, Mr :**

**Kitchen** see **Kichin :**

**Kitt** see **Savage, Kitt :**

**Knight, Mr :**

**Knott, Doc:** see **Nott, Dr**

**Ks ma<sup>tie</sup>:** the King’s Majesty, i.e. James I (1566–1625), king of Scotland, England, and Ireland.

**Labourer, Mr :** an associate.

**Ladd, Mr :**

**Laighton, Edward :** see **Laighton, Edward**

**Laighton or Laightone or Laiton, ‘Nedd’ or Edward :** a tailor.

**Lambert, Mr :** a collier.

**Lambert, Mrs :** a labourer.

**Lame, Mr :**



**Lancaster, Sar. :** **Sergeant Lancaster, of the King's Household.**

**Lane :** a jobbing labourer, whom Alleyn paid 5s p.w. from 11/10/1617 to 8/11/1617, 4s p.w. from 22/11/1617 to 6/12/1617. He and his wife dined with the Alleyns on 30/11/1617. Alleyn paid him 1s 6d for 12 ox bows on 1/12/1617, 8d for a pitchfork on 19/12/1617, and 6d (which he promptly lent Lane) for 4 more bows on 27/12/1617. On 1/1/1617[18] Alleyn received from Lane apples valued at 3d as a gift.

**Large, William :** 'Bayle' (i.e. bailiff) of Brixton Hundred, to whom Alleyn paid 5s on 19/12/1617 'for keeping me off juries'. Probably the same person as William Ladds, High Constable of Brixton Hundred in 1612 – DC MSS V 2.

**Laighton, Layghton, or Layton, Edward :** Either a Poor Scholar (although not recorded by Ormiston as such) or a boarder at DC. Son of Edward Layton, Waterman, and brother of Henry Layghton. (Both brothers were legatees in the 1615 Will of Alleyn's mother-in-law, Anne Henslowe, receiving respectively £50 and £30 after her death in April 1617.)

**Layghton or Layton, Henrie :** a 'poor scholar' at DC. Henry Layton, of Southwark, the first Poor Scholar, admitted 29th March 1617. Brother of Edward Layton. Provided with shoes until at least Oct. 1622. Later (from 1660) blacksmith, and lessee of a "small Tenement & Backside" fronting Dulwich Common at £1 p.a. Wife: Elizabeth. Died 15/11/1669 (when "the porter of this Colledge") and buried the following day.

**Lee, Mr :** 'Mr Lee & petty fares Mother' dined with Alleyn on 23/11/1617. Possibly they were a couple, but there is no record of a Lee/Pettifare marriage between 1604 and 1618. 'petty fare' was Richard Pettifare (q.v.), a Poor Scholar. 'Mr Lee' may have been Luke Lee, q.v., or John Lee, Sidesman of the Liberty of the Clink in 1610. 'Mr Lee preachers' and 'Mr Lees 2 brethren' dined with Alleyn on 7/12/1617.

**Lee, Luke :** a financier who held some of Philip Henslowe's debts. Alleyn paid him £4 in June 1618 'in full payment of all accountes & demaunds Dwe to Hym from P: Henslow'.

**Leech, Mr :** a scrivener.

**Lentford, Mr :**

**Lester, Lo: of :** Sir Robert Sidney (1563–1626), courtier and poet, Baron Sidney, 1603; Viscount Lisle, 1605; Earl of Leicester, 1618; younger brother of Sir Philip Sidney.

**Leunts, Sergeant :** a serjeant-at-law, paid 2s 6d by Alleyn "for an arrest at ye Suit of Luke Lee tymber man".

**Lewis, Aylec or Ayles :** Alice Lewis, a 'poor sister' or almswoman.

**Lewis or Lewiz, Goody** : possibly an alternate name for Alice Lewis  
**Lewis, John** : Aged at least 12 in 1579. Son of a Dulwich resident, John Lewis, tailor. A victualler after 1611. **Alleyn's tenant**. Last mentioned 30/9/1619. On 1/1/1617[18] Alleyn received from Jo: Lewis a capon and a pullet valued at 6d as a gift.

**Light, Mr.** ?The Muster Master for Camberwell.

**Lislaye, Richard** : Alleyn paid Ric: Lislaye £1 9s 0d (less £1 3s Lislaye owed him) on 21/12/1617 for 3,250 bricks for 'ye rownd turrets' provided 'this somer'.

**Lister or Lither, Dr** : **Matthew Lister (c.1564-1656)**, physician to Queen Anne and King Charles I. A Fellow of the College of Physicians from 1607. Knighted 1636.

**Lithell or Lither, Sam** : Sam Lithell was employed by Alleyn on 18/10/1617 to grub 12 rods (66ft) in Hamons [Coppice], and paid 6s, but the entry has been deleted. 'Lither' and three others (unnamed) were paid 5s for grubbing the orchard ditch at 8d a rod [=41' 3"] on 2/12/1617.

**Lo: canterbris maceber** : an abbreviation for Lord Canterbury's mace bearer; see Gillpine

**Lo: Chancellor** : Francis Bacon, Lord Verulam, who had objections to the issuing of the Letters Patent. Alleyn visited him on 17/8/1618.

**Lodg, Mr or Dr.** : **Thomas Lodge (1558-1625)**, physician and dramatist whose whereabouts Henslowe had refused to disclose after Lodge defaulted on a loan; mentioned in numerous DC manuscripts.

**Long, John** : probably John Longe, Alleyn's tenant, mentioned in Muniment 452. John, son of Thomas Longe, was baptised at St Giles Camberwell in April 1568.

**Longe, John** : Poor Scholar, admitted 6/9/1617, died 11/3/1617[18]. Given new shoes (10d) 8/11/1617.

**Lorayne, Duk of** : **Duke of Lorraine**; mentioned as Duke of Guise in DC MSS 28.

**Lord Chamberlain** : **William Herbert (1580-1630)**, 3rd Earl of Pembroke, Chancellor of University of Oxford, founder of Pembroke College, Oxford, and Lord Chamberlain 1615- 1625.

**Lord Chief Justice** : **Henry Montague (1563-1642)**, 1st Earl of Manchester and Lord Chief Justice of 1618-

**Lord of London** : **George Mountain Montaigne (1569-1628)**, Bishop of London, 1621-27; later archbishop of York.

**Lo: treserer or Lord Tresorer** : in 1617 the Lord High Treasurer of England was Thomas Howard, 1st Earl of Suffolk. **Henry Montague (1563-**

1642), was Lord Treasurer in 1620; Lionel Cranfield (1575–1645), first earl of Middlesex, merchant, financier, government minister, was Lord Treasurer from October 1621-May 1624.

**Loume, Mr :** a preacher.

**Lowen, John :** John Lowin (1576-1653), an actor in the King's Men from 1603, but previously a member of Worcester's Men, which had been financed by Henslowe

**Lo: wm :** Alleyn paid 'daggett that bid me to Lo: wm' 1s 0d on 24/12/1617. Prof. Ioppolo suggests that this was Sir William Cockayne, but he was not Lord Mayor until 1619, and the Lord Mayor in December 1617 was either Sir George Bolles or Sir Sebastian Hervey.

**Lowgoones** :

**Lucase, Andrew :** a defendant in a lawsuit that Alleyn had arrested; possibly a Southwark resident

**Luntley, John :** On 26/11/1617 Alleyn recorded that on 23/11/1617 'paid by watt [Haynes,] Luntlyes rent for [the Michaelmas quarter] in his debt to me & nowe I Have Received in ye rent £17 10s'. He paid another £3 10s rent to Luntly on 27/12/1617. On 28/1/1623 John Luntley, gent., of The White Lion, Southwark, and his wife Rebecca, assigned to Matthias Alleyn of Dulwich, 'yeoman' £7 rent (for half a year) for tenements on the Bankside leased by them to Alleyn (DC MSS III 94 and V 36).

**Lydall :** a grubber, or fieldworker.

**Lyle, Christopher :** formerly a tenant of Henslowe; mentioned in Muniment 146.

**Lymare, Cornelius :** Revd. Cornelius Lymer, 1st (Preacher) Fellow appointed 31/8/1616, left 30/9/1617; mentioned in DC MSS 3, Article 66. Previously (from 1605) Chaplain of Christ Church College, Oxford.

## M

**Magett, Mr :**

**Man, Aylec :** Alice Man, a 'poor sister', or almswoman.

**Man or Mann, Robert :** a 'poor scholar' at DC. "of Peckham", according to Ormiston's Register. Admitted Sept. 1617. Provided with shoes until at least Oct. 1622.

**Maning, Mr :** a coal dealer; mentioned in DC MSS 5, Article 35.

**Mansell, Dorathie :** Not a Dulwich tenant; presumably a 'live-in' servant.

**Marie or Mary :** Alleyn's servant.

**Marsh, Mr :** probably Peter Marsh, a gentleman mentioned in numerous DC manuscripts about land purchases.

**Marshall, Mr :** possibly John Marshall, a cook mentioned in Muniment 165.

**Martin or Martine :**

**Martinot, Mr :** one of Alleyn's debtors.

**Mason, Goody :** ?Widow of John Mason (a Dulwich resident last mentioned 22/11/1592). On 28/12/1617 Goody Mason brought a cake to dinner, and on 1/1/1617[18] Alleyn received from her 'a great cake' [?the same one] as a gift.

**Mason, Mr :** a blacksmith.

**Mason, Mr :** a witness in one of Alleyn's legal proceedings; possibly the same Mr Mason who worked as a blacksmith for Alleyn.

**Massie or Massey, Charles :** Charles Massey, dramatist and joint-lessee in the Fortune theatre; mentioned in numerous DC manuscripts.

**Massie or Massy, Charles :** a collier.

**M<sup>r</sup> of the Barge :** Master of the Barge.

**M<sup>r</sup> of the Rowls :** Master of the Rolls, Sir Julius Caesar (1558-1636), civil lawyer; mentioned in DC MSS 2, Article 1, and Muniment 170.

**Math or Mathias, Ja. :** a tailor.

**Mathew, John :** Alleyn's tenant; mentioned in DC MSS 5, Article 2, and Muniments 416 and 468. John Mathew & his (unnamed) wife dined with the Alleyns on 26/12/1617. Aged at least 12 in 1586 (and probably born 1568). A tenant (initially of Thomas Calton) of a house & 11 acres in Napps from 1597. Not recorded in manor court rolls after 1615.

**Mathew, Will:** 'will: mathew' and his wife dined with Alleyn on 7/12/1617, and sold him a bushel of pins (for 1s 4d) on 13/12/1617. Although from 1624 there was another William Mathew (a mariner, from Rotherhithe) as a Dulwich tenant, this is probably William Mathew or Mathewe (1583-1652), yeoman/labourer, a Dulwich resident since 1611 and tenant of 10 acres from 1626 or earlier. No reliable record of his marriage or death (except that 'Widow Mathewes' took over his holding at 25/3/1652).

**Matthew, H :** probably Henry Matthew, one of Alleyn's tenants, mentioned in DC MSS 5, Article 2 and Muniment 417.

**Matthew, Widoe :** a 'poor sister' or almswoman; previously resident in Southwark.

**Maund, Mr :**

**Maunsell, Mr :** probably the husband of Dorothy Mansell.

**Maye, Readinge :**

**Mayer, Lord** see Lord Mayor

**Maynerd, Mr :**

**Meade, Jacob :** a waterman who had a variety of business dealings with Henslowe and Alleyn, including at the Bear Garden; mentioned in numerous DC manuscripts.

**Mecop, Peter :** Peter Mecop or Meecup, a bricklayer originally from Holland and a Southwark resident; mentioned in Muniment 173.

**Megg :** a servant or almswoman.

**Meridall or Merydale, Richard :** a poor scholar at DC who had been recommended by Stephen Gosson; mentioned in DC MSS 3, Article 76.

Richard, son of Richard Merydale, was baptised at St Botolph's, Bishopsgate, on 10th April 1604. Admitted 6/9/1617. Left before 17/3/1621[22].

**Mers, Mr :** debtor to Alleyn.

**Michell or Mighell or Mihell, Mr :**

**Milberry, Mr :** an associate of Alleyn.

**Mill, Mr :** a scrivener.

**Millayne, Mrs :** possibly the wife of John Millen.

**Millin, Mr :** John Millin or Millen, who leased property to Alleyn; mentioned in DC MSS 3, Article 112, and Muniment 178

**Mincshawe, Mr :** John Mishen, author of *Doctor in Linguae: The Guide into the [Eleven] Tongues* (1617) and *Vocabularium Hispanico-Latinum et Anglicum copiosissimum* (1617).

**Mondy, Mr :** see Munday

**More, Mr :** see **More, Sir Richard**. A lawyer involved (probably as an arbitrator, with Mr Wolveridge, q.v.) in William Henslowe's suit in 1617.

**More, Sir Richard** a Master in Chancery, of the Inner Temple; mentioned in DC MSS 3, Article 99; or possibly Richard More (c.1575–1643), the religious writer and politician

**Moreis, Ric:** see **Morris, Ric:**

**Morgan, Mr :** probably John Morgan, mentioned in DC MSS 2, Article 19, and MSS 5, Article 6. Mr Morgane dined with Alleyn on 7/12/1617.

**Morris, Ric:**

**Morton :** On 30/5/1618 Alleyn paid 'mortone' 5s 'for y<sup>e</sup> tyeths of y<sup>e</sup> fortune', and another 12s 'for y<sup>e</sup> consecration daye waighting He & His fellowe'. Young comments : "Probably for waiting at the dinner on the day of the consecration of the chapel, 13th September 1616; but it seems curious that twenty months should elapse before payment is made of so small a matter". Perhaps Morton took the opportunity when meeting Alleyn to remind him that he had forgotten to pay.

**Morton or Mortone, Mr :** a Fortune Theatre tenant, used by Alleyn as an intermediary for paying ‘ye fortune quitt rent’ on 11/11/1617.

**Mosse, Marye :** Alleyn’s servant.

**Moyeses :**

**Munday, Mr :** Antony Munday, (1560-1633), a dramatist with a long association with Henslowe and Alleyn; mentioned at various points in DC MSS 7 (Henslowe’s Diary).

**Muse, Mr :** a labourer; probably an abbreviation of **Musgrove**.

**Musgrove :** a labourer.

**Myddleton, Mr :** probably the dramatist Thomas Middleton (1580-1627), who had a long association with Henslowe and Alleyn; mentioned at various points in DC MSS 7 (Henslowe’s Diary).

**Myetone, William :** husband of Jugg (or Joan) Allen.

**Mylyon, Mr :**

N

**Natt, Doctor** see **Nott, Dr**

**Ned** see **Ned Alleyn**

**Newman, Robert** Robert Newman, possibly a lawyer, was the son-in-law of Alleyn’s cousin Edward Alleyn of Newport Pagnell, and wrote to Alleyn on 27th July 1617 describing the outcome of a murder trial of concern to the Alleyn family (DC MSS 3, Article 75). ‘newman’ had supper with Alleyn at The Cardinal’s Hat on 17/12/1617.

**Newton, Mrs :** probably the wife of the actor John Newton who is mentioned in DC MSS 1, 107 and 110.

**Nick :** a bricklayer.

**Northop, Henry :**

**Nott, Dr :** Dr Nott (first name never mentioned) was a Dulwich tenant. Dined with Alleyn on 5/10/1617 and 19/10/1617. On 1/1/1617[18] Alleyn received from Doc: nott two cocks valued at 6d as a gift.

**Nowleboy, W :** Dined with Alleyn on 5/10/1617. Both Prof. Ioppolo and William Young have read the name as ‘Nowleboy’, but it could be ‘Rowleboy’. Either way, there is no other record of him (or her).

**Noxe, Mr :**

**Offey :**

**Oker, Mr :**

**Okey, Mr Jo. :** a barber and Southwark resident.

**O’Kirton :** Ann Kirton, a ‘poor sister’, or almswoman.

**Only, Mr :** an associate of Alleyn who lived in Sydenham.

**Ordse :** an agent to whom Alleyn paid tithes.

**Ortford, Robert :**

**Osborne, Mr :** a scrivener.

**Osborne, Sir John :** the Treasurer’s Remembrancer from 1592; mentioned in MS 27.

**Otte, Ottey, Oattey, Mr :** On 28/12/1617 ‘otter’ and his wife dined with the Alleyns. An unrecorded Dulwich resident?

**Overman, Mr :**

**Owdse, Mr :** Alleyn dined with Mr Austen, Mr Archer & Mr Owdse [?Olds/?Ordse] at The Cardinal’s Hat on 12/12/1617.

**Owen, Sar. :** Serjeant Owen, of the King’s household; mentioned in DC MSS 3, Article 88.

**Owld, Mr :** a legal clerk.

## P

**Padmore, Mr :** Philip Padmore, Alleyn’s tenant in Dulwich; mentioned in Muniments 553 and 580. Padmore had married Marie or Mary Townley, widow of Alleyn’s probable kinsman John Townley Esq., of Grays Inn (a Dulwich tenant since 1608), and took over Townley’s lease of a house & 36½ acres.

**Page, Mr :** a carpenter.

**Pagett, Goodman :**

**Pagett, Goody :** wife of Goodman Pagett.

**Palmer, Mr :**

**Parck, Mr :** a labourer.

**Pard, Mr :** see Pare.

**Pare, Muse :**

**Pare, Dic :** Richard Pare, a husbandman and Alleyn’s tenant; mentioned in DC MSS 5, Article 2 and 544. Richard Pare, born c. 1558, was lessee of the site of the Green Man at the junction of Dulwich Common and Lordship Lane from before 1606 to his death in late 1648. He and his wife (whose father, name unknown, died c.1618, was a Dulwich resident) dined with Alleyn 16/11/1617.

**Parkins, Sir Charles :**

**Parr or Parre, William :** actor and joint-lessee of the Fortune Theatre; mentioned in Muniment 56-57. ‘Cartwright gannell & parr’, all members of the Fortune company, dined with the Alleyns on 22/3/1617[18].

**Peare.** See **Pare**

**Pecock, Mr :** a carpenter.

**Pedle, Mr :**

**Perie or Perrie.** See **Pare**

**Perie, Perrie, Perre, Parrey or Perry, Will. :** a labourer.

**Perine, Mr :**

**Perrie, Goody :** a labourer.

**Perry :** On 26/12/1617 'perie & His [unnamed] wife' dined with the Alleyns. This could be Richard Perry (Dulwich resident 1621-1641), or William Perry (resident in 1620-21), or even Richard Pare, q.v.

**Perry, Richard :** a labourer.

**Person :** On 27/12/1617 'person brought a small shuger loaf', and on 1/1/1617[18] Alleyn received from him 'a sugar loafe' [?the same one] as a gift.. (Possibly 'Person' was an unrecorded Dulwich resident.)

**Pert, Captain :**

**Pettyfare or Pettifare, Ric. :** Richard Pettyfar, a 'poor scholar'. Richard, son of Thomas Pettifer, baptised at St Giles, Cripplegate, on 5th January 1610[?11]. Admitted 6/9/1617. Provided with shoes until at least Oct. 1622.

**Pettyfore, Mrs :** probably the mother of Richard Pettyfar.

**Phillcocks, Mr :**

**Pierc, Mr :**

**Pitts, Mr :** a lawyer, to whose clerk Alleyn paid 1s for a recognizance certificate on 17/12/1617, and 10s to Mr Pittes himself 'for 3 dischargings his book'.

**Place, Mr :** Alleyn's associate

**Poell, Doc. :**

**Pole, Goodman :** He and his wife dined with Alleyn on 7/12/1617. Possibly William Poole, Camberwell brewer, fined at the manor court for selling short measure to local hostellers in 1610 and 1611. Otherwise there was no Dulwich resident named Pole, Poole or Powell at this time.

**Poply, Widow :** a defendant in one of Alleyn's lawsuits.

**Potts, Mr :** a witness in one of Alleyn's lawsuits.

**Powlsted, Henry :** Henry Polsted, a royal official who had been involved in a property arrangement for Queen Elizabeth in 1552; mentioned in Muniment 174.

**Price, Mr :** an actor in the Prince of Bohemia's, i.e. 'Palatine's or Palsgrave's' Men and joint lessee of the Fortune Theatre; mentioned in Muniments 56-57, 59 and 67-68.



**Princes men :** The Prince's Men, the acting company patronized by Henry, Prince of Wales, and with which Alleyn had a long association.

**Priss, Doc :** Alleyn refers to him as a preacher; possibly Sampson Price (1585/6–1630), a London-based Church of England clergyman and religious writer.

**Pryme, Mr :** a preacher from Cambridge.

**Pullman, Ellsibeth or Bess :** a servant, generally referred to as 'Bess'.

**Pye or Pie, Mr :** a scrivener.

## Q

**Quarrell, George :** Alleyn's servant; frequently referred to simply as 'George'. George Quarrell was, as well as being Alleyn's servant, tenant of a house and 11 acres west of Dulwich Common. Succeeded after March 1626 by his widow Bethia.

**Queen of Boheame :** Elizabeth Stuart (1596–1662), Queen of Bohemia and Electress Palatine, consort of Frederick V; daughter of James I and Queen Anne.

## R

**Ratline, Mr :** Alleyn's tenant.

**Rame, Mr :** a horse gelder living in James Street in Westminster.

**Ranscroft, Mr :**

**Ransome, Ransun, or Ramsum, Mr :** Alleyn paid 'Ransome' 7s for cleaning 6 loads of wood on 5/11/1617. Probably Thomas Ransome, Ramsum Ransom or Ranson, who (with Faver Fox) leased the tile kiln on Dulwich Common in 1617 to 1629 (and possibly from its construction in 1618).

**Ratclyf, Doc. :** Dr Ratcliff, Master of Brasenose College, Oxford

**Read, James :** probably the James Read who was a minister and Southwark resident

**Reading :** 'Reading' and his wife dined with the Alleyns on 30/11/1617. Possibly Revd. Joseph Reding, although he was not appointed 1st (Preacher) Fellow of DC until 25/8/1626 and left (oddly close to Alleyn's death) on 21/11/1626. Since Fellows of DC had to be single, either his wife had died between 1618 and 1626 or this was a different Reading, possibly Edmund Redman, whom Alleyn misnamed elsewhere.)

**Reason, Balye :** Bailiff Reason, a local bailiff.

**Redhed, Goody or Mrs :** a labourer.

**Redhed, Mr :** a carpenter.

**Reding, Abram** : probably a relative of the Joseph Reding mentioned in Muniment 594, which constitute the Statutes and Ordinances of DC.

**Redding, Edward** : Alleyn's error for Edmund **Redman**, q.v.

**Redman, Dan.** : **Alleyn's tenant.**

**Redman, Edmund** : Alleyn records that on 21/12/1617 'Edward Redding Had a sone baptized by y<sup>e</sup> name of John'. The Chapel Register (MSS X) records that on 21/12/1617 John, son of Edmund Redman, was baptised. From Nov. 1626 (and probably earlier) to 1635 Redman was lessee of a house, orchard, and 29 acres (Crouchmans, Annis fields and Dickariddings) and later, until his death in 1641, of John Casinghurst's house & 36 acres. He had married Casinghurst's daughter Dionis (or Denise), who succeeded him until 1670.

**Redman, John** : see **Redman, Edmund.**

**Reeves** :

**Regnowlds, Jo.** : **a labourer.**

**Ric.** : Probably Richard Baron or Baran, son of the 'barrone' who worked occasionally for Alleyn in 1617.

**Rice, Mr** : **probably John Rice, an actor in the King's Men and the Lady Elizabeth's Men and mentioned in DC Muniment 47 and MSS 18, Article 9.**

**Richardson, Mr** : **a preacher.** Dined and supped with Alleyn on 2/11/1617, and Alleyn paid him 5s.

**Risbury, Adam** : **a labourer.**

**Robarts, Mr** : **an official in the King's household.**

**Robert** : **the servant of Bailiff Large.**

**Robin** :

**Robinsone, Mr** : **either Thomas Robinson, the actor and Fortune theatre joint-lessee mentioned in DC MSS 1, Article 116, or the Robert Robinson, a white-baker, mentioned in MSS 4, Article 28.**

**Roger** : **a brewer.**

**Rogers** : According to Ormiston, three brothers of that name were admitted to DC as boarders on 15/6/1620 but left on 21/10/1620.

**Rogers, Doc.** :

**Rogers, Mr** : **possibly the Edmond Rogers, a tailor and one of Alleyn's tenants, mentioned in Muniment 573.**

**Rolfe, Anne** : **a 'poor sister', or almswoman.**

**Rop, Henrie** : **Henry Roper, a gentleman of Lincoln's Inn; mentioned in Muniments 448, 486 and 528-29.**

**Rowland** :

**Rowleboy, W. :** see **Nowleboy, W. :**

**Roydon, Mr :** Matthew Roydon, a poet, to whom Alleyn gave 1s on 13/10/1617 and 6d on 15/8/1622.

**Rundle, Mr :**

**Russell, John :** probably the theatrical ‘gatherer’ of Cripplegate mentioned in DC MSS 1, Article 104 and Muniment 58.

**Russell, Widow :**

**Ruthin, Mr :** a fellow of DC. Revd. Christopher Reuthen, appointed Third Fellow (Usher) on 24/12/1621. Left 28/9/1623.

## S

**Sackville, Sir Ed. :** Edward Sackville, fourth earl of Dorset (1590–1652), politician.

**St bees :**

**Sanders or Sandors :** a merchant, or James Saunders, a ‘poor brother’ or almsman

**Sandon, Franc (i.e. Francis) :** a labourer

**Sarah :** a servant.

**Savage, Kitt :** ‘Kitt’ was presumably a live-in dependant, or unpaid servant, at DC, although Ormiston records him as a Poor Scholar. Alleyn paid 4s for ‘2 pr’ of shoes for ‘Kitt & Bess’ on 11/10/1617, 1d for ‘whipcord for Kitt on 27/10/1617, and 3d for ‘mending Kitts shoes’ on 11/12/1617. On 10/3/1617[18] ‘Kitt Savage went away’. Alleyn paid for his apprenticeship on 9/5/1618. A Christopher Savage was a Dulwich resident and tenant from 1590, and in 1614 (with his wife Agnes) occupied the Old Blew House, but died in 1616. However, the court rolls for 1611 refer to ‘Chris Savage the younger’, who could be ‘Kitt’.

**Scplt, Mrs :**

**Scott, John :** a labourer.

**Scott, Sir Peter :** Involved (as Peter Scott of Camberwell) with Alleyn in a property deal in 1613-14. Possibly the ‘Mr Skott’ who journeyed to Lambeth with Alleyn on 14/11/1617.

**Scriuener or Skrivener, John :** John Scrivener, Alleyn’s husbandman; mentioned in DC MSS 6, Article 3. John Scrivener, born c. 1599, became a tenant of the College, holding 2 houses and 4 acres at £8 p.a. Became a victualler. Twice married, first to Hannah, then (in 1635[36]) to Elizabeth Davies. Died c.1639 – his widow remarried on 22/3/1640[41].

**Scull, Ned :** a servant.

**Sedley, Mr :** Richard Sedley, one of Alleyn's landlords; mentioned in Muniment 183.

**See, Luke :** a timber dealer. See Lee, Luke

**Seeley :**

**Sercher of Kent :**

**Sharpe, Mr :** a grubber.

**Sharpe, Mr :** a tanner.

**Sharpe, Mr :** a lawyer or scrivener.

**Shaw, Mr :** an official of Croydon Hospital.

**Sheey, Tho. :**

**Shellstone :**

**Shelton, Mr :** steward of Kennington; possibly Sir Richard Shelton (1578–1647), lawyer and politician.

**Shepey, Sheppey, or Shippey, Thomas :** Poor Scholar at DC who had been recommended by Stephen Gosson; mentioned in DC MSS 3, Article 76. According to Ormiston's Register, Thomas Shepey, Sheppe, etc., from Bishopsgate, was aged "about 8" on admission in Sept. 1617, the son of a widow who had remarried by Sept. 1618 (possibly to John Shippey in 1605). Provided with shoes until at least Oct. 1622.

**Sheppd, Mr :** an abbreviation for Mr Sheppard, Sarah Sheppard's father

**Sheppd, Sarah :** Sarah Sheppard, a 'poor sister', or almswoman

**Sherman, Mr :** a preacher.

**Sherman, Mrs :**

**Sherwood, Mr :** a labourer.

**Shillingford, Mr :** a blacksmith.

**Shingleton, Mr :**

**Shippey, Thomas :** see Shepey, Thomas

**Shreeve off Surrey :** Sir Richard Michelborne, Sheriff of Surrey.

**Sidon, Mr :**

**Siluer or Silver, Thomas :** a labourer and Southwark resident.

**Skinner, John :**

**Skott, Mr :** Alleyn crossed to Lambeth and back by water with 'Mr Skott' on 14/11/1617. See Scott.

**Skragg, Mr :** Alleyn's associate.

**Smith, Mr :** Alleyn's cook.

**Snell :** 'beck: snell & His wife' dined with the Alleyns on 26/10/1617. Acquaintances of Alleyn – not recorded as Dulwich residents.

**Snellgar, Sir Harry :**

**Sparrow** : probably Richard Sparrow, a 'poor scholar' at DC recommended by Stephen Gosson in MSS 3, item 91.

**Speaker, Mr of the Chamber** : Master Speaker of Star Chamber.

**Spencer, Mr** : possibly the Michael Spencer, oar-maker, mentioned in Muniment 266.

**Spring, Mr** :

**Stacie, Thomas** : Alleyn's gardener.

**Stanes** : probably the Henry Stane sued by Alleyn over a debt in 1614 and mentioned in DC MSS 5, Article 18.

**Stanley, Tomasine** : a 'poor sister' or almswoman.

**Staple or Staples, Arthur** : Alleyn's tenant or labourer.

**Staple or Staples, Goody** : wife of Arthur.

**Staple or Staples, John** : Alleyn's tenant; mentioned in DC MSS 5, Article 2. John Staple was the son and successor as a Dulwich tenant of John Staple senior (referred to as such in 1608, first mentioned 1586), Camberwell yeoman. Last mention 3/10/1623. Father of Nicholas Staple(s) (born 1618). Dined with Alleyn on 23/11/1617. On 1/1/1617[18] Alleyn received from Jo: boger a capon and a hen valued at 6d as a gift. On 4/1/1617[18] 'Jo: Stapl' & his wife dined with the Alleyns.

**Starkey** : Either John Starkey, Dulwich resident 1602-1626, or more likely Robert Starkey, Dulwich tenant of a house & 14 acres (and another 10 acres) in Napps, 1606-1634. 'starkey' dined with the Alleyns on 26/12/1617. Succeeded to tenancy by his son John (baptised 17/5/1607 at St Giles).

**Starkey, Mr and Mrs** : probably James Starkey, a Master of the Bears mentioned in DC MSS 2, Article 23 and 24, and MSS 18, Article 12, and his wife; residents of Southwark.

**Stats, Mr and Mrs** :

**Staughton**. See Stoughton

**Staughton, Mr E.** : Edward Stoughton, a constable and resident of Streatham; mentioned in DC Muniment 418. Son of Richard Stoughton (q.v.) Dined with Alleyn on 16/11/1617 (one week after his father did).

**Steele, Mr** :

**Stendall or Stedall, Sir Francis** :

**Steuens, Steeuens or Stevens** : a labourer. Probably John Stephens, a Dulwich resident 1611-1619. He and his wife (name unknown) dined with Alleyn on 16/11/1617.

**Steuens or Steuens, Goody** : a female labourer.

**Stile or Style, Mr** : a seed-dealer.

**Stock, Mr** : probably the John Stock, a haberdasher and Alleyn's tenant, mentioned in DC MSS 3, Article 122 and DC Muniment MSS 579.

**Stoddard, Sir Nic.** : Sir Nicholas Stoddard of Mottingham, lessee of Lewisham manor; mentioned in DC MSS 5, Article 37.

**Stoferd, Stoford, Mr** :

**Stokes** : Lady Clark's servant. Alleyn tipped him 2s 6d on 1/1/1617[18].

**Stoks, Goody** : probably Martha, the wife of John Stock, cited in DC MSS 3, Article 122

**Stoughton, Richard** : Richard Stoughton (q.v.), Stauton, Staughton or Stawton was a Dulwich tenant (but not necessarily resident) from 1598 to 1633. Dined with Alleyn 9/11/1617. On 1/1/1617[18] Alleyn received from 'stoughton' two pullets valued at 1s as a gift. Married to Elizabeth. Father of Edward Staughton, q.v. N.B. Richard Stauton was the "apysse Jacke [i.e. jackanapes] Stauton [not Stanton]" referred to in MSS 3, item 74, on 24/7/1617.

**Strangewish, Mr** :

**Stuckey** : a servant.

**Styls, Mr** : probably William Style, mentioned in DC 3, Article 123.

**Swift** : Although clearly known to Alleyn, 'Swift' has not been identified.

**Swing** :

**Sym** : a Poor Scholar, according to Ormiston, first name unrecorded, admitted prior to 5/8/1620. Provided with shoes until at least Oct. 1622.

**Symonds, Mr** : Dined with Alleyn 9/11/1617. Probably William Symons, a Lambeth shipwright, lessee of a wharf in the manor of Kennington, or possibly Revd. Martyn Symonds, q.v., or Revd. Peter Symonds, q.v., or possibly none of them.

**Symonds, Martyn** : an usher and fellow at DC. Revd. Martyn or Martin Symonds, appointed Third Fellow (Usher) on 29/9/1618, promoted to Second Fellow (Schoolmaster) on 28/9/1620. Left 28/9/1623.

**Symonds, Peter** : a fellow of DC. Revd. Peter Symonds, appointed Third Fellow (Usher) on 3/11/1620. Left 3/11/1621.

**Sythen, Mr** Alleyn's tenant who lived in Golding lane, the location of the Fortune playhouse

T

**Talboyes or Taylboyce, Mr** : see Tayleboyce.

**Tapley, Mr** :

**Tayleboyce, Richard** : Richard Tailboys or Talboyce, a lawyer of the Inner Temple and a Dulwich tenant. Witnessed the Foundation Deed and one of the guests at the Foundation Dinner on 13/9/1619.

**Taylor, Jo.** : John Taylor (1578-1653), the water poet, who received a subscription from Alleyn for his walk from London to Scotland; mentioned in DC MSS 18, Article 9

**Taylor, Jo.** : Joseph Taylor (c1586-1652), an actor in Prince Charles's Men and the King's Men from 1619, and later an actor-manager; previously with the Lady Elizabeth's Men, through which he had financial dealings with Henslowe; mentioned in numerous DC manuscripts.

**Taylor, Tho.** : a labourer.

**Terey or Terrye** : a baker.

**Thicknis, Mr** : an associate.

**Thomas** : Lady Clark's servant. Alleyn tipped him 2s 6d on 1/1/1617[18].

**Thomsone or Tomsone, Francis** : a Southwark resident.

**Tichebourne.** see **Tuchborne**

**Toby** : a servant.

**Tom** : see **Ellice, Thomas**

**Tonstall.** See **Tunstall.**

**Townley or Townshey, Mr E.** : On 6/1/1617[18] 'Mr E townle & all ye pore supt with us'. On 4/1/1617[18] 'M<sup>r</sup> E townshey' dined with the Alleyns, and on 6/1/1617[18] 'M<sup>r</sup> E townle & all y<sup>e</sup> pore supt with us'. Presumably a relation of Alleyn's on his mother's side.

**Trattorns, Mr** :

**Travis or Travise, Edmond** : London haberdasher who (with his wife Susanna) on 26/3/1617 granted Alleyn a 50-year lease of houses in Blackfriars, which he much later alleged (DC Mun. 184) they had covenanted to sell to him. Alleyn paid £40 as 'Mr Travise rent for ye blackfryars' on 22/10/1617.

**Trebeck or Trebuich, Mr** :

**Trogarth, Mr** : a tailor.

**Trott** : On 30/12/1617 Alleyn paid 'trott' 5s 'for this quarter rent gathering'.

**Tuchborne, Mr** : Leonell or Lionel Ticheborne or Tycheborne, a scrivener or lawyer who dealt with Alleyn's legal manuscripts; mentioned in numerous DC manuscripts. Alleyn (who almost invariably spells the name as 'tuchborne') dined with him in London on 3/12/1617 after a sealing ceremony at York House, and again (at The Pole Head) on 6/12/1617, and visited him on 12/12/1617. On 1/1/1617[18] Alleyn paid Tuchborne's bill

for Michaelmas Term, totalling £5 7s 4d (for 19 items) in respect of Alleyn's action against William Henslowe. Later that day Alleyn spent 1s on wine with him.

**Tumber, Mr :**

**Tunstall, Sir John :** Witnessed the Foundation Deed and one of the guests invited to the Foundation Dinner on 13/9/1619.

**Turner :** a Smith. Alleyn paid him 2s 6d on 21/12/1617 for two steel locks.

**Turner, Sir Jerimy :** **Sir Jeremy Turner, Captain of the Surrey bands; mentioned in MS 1, Article 56.**

**Tychebourne.** See **Tuchborne**

**Tyess, Mr :**

**Tyghton, Widow :**

**Tylley, Bess:** Presumably a live-in dependant, or unpaid servant, at DC. On 11/10/1617 Alleyn paid 2s for a pair [of shoes] for 'Bess', and on 27/10/1617 10d for 'making besses wastcote & tape'. On 27/12/1617 he gave 'bess tylley' 1s.

**Tylley :** Alleyn paid 'tylley' 10d on 4/10/1617 for Monday [29/9/1617] 'att y<sup>e</sup> stack', and received from vnderwode/Vnderwood and tylley (to both of whom he had paid 16s 4d for 'sawing for ye Oxe Howse' on 11/10/1617) 1s and 6d respectively, as some form of rent. Again 6d on 18/10/1617, 25/10/1617, 1/11/1617, 8/11/1617 (but not 15/11/1617).

**Tyllsley, Mr :** Thomas Tillesley, of Camberwell, gentleman, Alleyn's lessee of a house and 12 acres (Addingtons Meads) and another 16 acres, at £32 in all, from 26/9/1618.

**Tyse, Mr :** **a silk dealer.**

U

**Udall, Sir W. :** **Sir William Uvedale, Treasurer of the Chamber.**

**Underwood, Alice :** daughter of John Underwood, baptised Sunday, 14/12/1617.

**Underwood, Hew :** Hugh Underwood, according to Prof. Ioppolo, was 'probably Alleyn's secretary; mentioned in DC MSS 3, Article 108', but that was Henry Underwood, Steward of Dulwich manor in 1626 in succession to John Harryes. 'Hew Vnderwood & His wife' dined with Alleyn on 2/11/1617. There is no evidence that Alleyn ever had a Secretary.

**Underwood, John :** **a servant; previously a Southwark resident.** Alleyn received from vnderwode/ Vnderwood and tylley (to both of whom he had paid 16s 4d for 'sawing for ye Oxe Howse' on 11/10/1617) 1s and 6d respectively, as some form of rent. Again 1s 6d on 18/10/1617, 25/10/1617,



1/11/1617, 8/11/1617, 15/11/1617, 22/11/1617, 29/11/1617, 6/12/1617, 12/12/1617. His daughter Alice was baptised in the afternoon of 14/12/1617, as recorded by Alleyn (?and by the Chapel Register, MSS X). Alleyn paid him £1 0s 5d on 20/12/1617 ‘for 800/ & 3 q’, and on 5/1/1617[18] 4s 8d for sawing ‘200/’ for the ox house.

**Ursula :** ‘Vrsula’, Lady Clark’s servant. Alleyn tipped her 2s 6d on 1/1/1617[18].

## V

**Vans, Vanse or Vase, Mr :** Revd. Robert Vance, appointed First Fellow (Preacher) on 28/9/1620. Left 24/12/1620.

**Varney, Raphe :** probably Ralph Verney (1613–1696), son of Sir Edmund Verney (1590- 1642), and later first baronet.

**Vaughan, Madlyn :** Magdalen Vaughan, probably the landlord to whom Alleyn made a payment mentioned in Muniment 180.

**Vaughane, Mr :** possibly Edward Vaughan, mentioned in Muniment 95.

**Vincent, Mr :** David Vincent, Groom of the Privy Chamber; mentioned in Muniment 76.

## W

**Wadop or Waddope :** Simon Waddup, a poor scholar at DC who had been recommended by Stephen Gosson; mentioned in DC MSS 3, Article 76.

Symon Waddop, son of William Waddop, baptised at St Botolph’s, Bishopsgate, on 1st January 1609[10]. Admitted Sept. 1617 – father lame and “past his labour”. Provided with shoes until 4/8/1621.

**Walker, Goodman :** Alleyn’s associate.

**Wakerley, Mr :** a woodworker.

**Walker, Mr :** a labourer. On 28/12/1617 ‘Walker’ and his wife dined with the Alleyns. Probably Thomas Walker, a Dulwich resident from 1602 to at least 1615.

**Walter or Walters, Thomas :** a servant.

**Walthian, Mr :**

**Ward :** Dined with Alleyn 9/11/1617. Probably Richard Warde, a Dulwich resident (initially in Thomas Abeck’s house) from 1607 to 1623.

**Ward, Mr :**

**Ward, Goody :** probably Katherine Ward, wife of Thomas Ward, mentioned in Muniments 365-68, 388 and 392-95, according to Prof. Ioppolo, but neither Kathering Ward (née Wright) nor her husband Thomas Ward had had any involvement with Dulwich since 1592.

**Warner, Mr :** probably John Warner, Rector of St Dionis, London and afterwards Bishop of Rochester; mentioned in DC MSS 3, 79.

**Washington, Mr :** a lawyer to whom Alleyn paid 1s on 17/12/1617 for signing/entering a Chancery Order.

**Watford, Ed. :**

**Watson, Lady :** wife of Sir Thomas.

**Watsons, Sir Thomas :** one of Alleyn's landlords.

**Watt:** see Haynes, Walter

**Watt, Nowe :**

**Weathered, Thomas :** probably the Thomas Weatherhead who was a Southwark resident.

**Webb, Mr :** a constable.

**Welch or Welsh Will :** a 'poor scholar' at DC, or more likely one of Alleyn's workmen.

**West :** 'West' grubbed Furzie Field for Alleyn on 11/10/1617. A loan to 'West & His partner' of 3s 6d on the same day has been deleted.

**West, Mr and Mrs :** possibly John West, a woodmonger, mentioned in DC Muniment 121, and his wife.

**Westwood, Mrs :**

**Whaley, Mr :** a sheriff or bailiff.

**Whight, Mr :** a scrivener.

**Whip, Nan :** a servant.

**Whittaker, Laurence :** Laurence Whitaker (1577/8–1654), a politician and clerk extraordinary to the Privy Council from 1624 until 1642.

**Wicherley, Maudlyn :** Madelyn Whicherly, servant to Edward Alleyn's wife Joan.

**Wie, Mr :** a High Constable.

**Wightman :** Thomas Wightman, a defendant in one of Alleyn's lawsuits over Dulwich property; mentioned in DC MSS 18, Article 10.

**Wigington, Mr :** a dyer; mentioned in Muniment 172. On 1/1/1617[18] Alleyn received from 'M': wigington' a sugar loaf as a gift.

**Wigpitt, Mr :** Thomas Wiggett or Wigpitt, joint-lessees of the Fortune Theatre; mentioned in DC MSS 1, Article 115 and Muniments 67-69

**Wildgoss, Sir John :** Sir John Wildgosse, who held the manor of Lewisham which Alleyn bought; mentioned in DC MSS 5, Article 37 and Muniment 183.

**Will:** see Ashbye

**Willett, Mr :** a blacksmith.

**Willford, Henrie :** a servant.

**Willson, Mr :** Alleyn calls him a 'a singer'; probably John Wilson (1595–1674), composer and musician in the King's Men from 1611.

**Willson, Mr Edward :** the vicar of Camberwell. Watt [Haynes] paid 'Mr Willsons rent' [?for Camberwell advowson] of £2 10s on Alleyn's behalf on 20/10/1617, and again on 4/1/1617[18].

**Willson or Wissone, Samwell or Samuel :** Revd. Samuel Wilson, M.A., a preacher and fellow at DC. Appointed as First Fellow (Preacher) on 29/9/1618. Left 28/9/1620.

**Willson, Mr :** a baker.

**Winche or Winchester, Lord or Bishop of :** James Montague 1616-18. Lancelot Andrewes (1618-26). The Alleyns dined with Bishop Montague on 29/12/1617.

**Windsor, George :** a Southwark resident

**Winter :**

**Withers, Mrs :** née Hellen Sparkes. She and her husband Matthew (married 27/6/1597) dined with Alleyn on 12/10/1617.

**Withers, Matthew :** a gardener of Camberwell, to whom in January 1607 Alleyn leased a house & yard (3 acres), Norcrofts (12 acres) Great Bornes (12 acres) and Woodsire Grove (8 acres), for 31 years at £24 p.a. Last mentioned 1622. Mentioned in DC Muniments 505. On 1/1/1617[18] Alleyn received from 'math: withers' a loin of pork valued at 6d as a gift. On 4/1/1617[18] 'mathew withers' & his wife dined with the Alleyns.

**Wolfe or Woulfe, Rich. :** a Southwark resident.

**Wolveridge, Master :** John Wolveridge, a Master in Chancery; mentioned in MSS 5, Article 28.

**Wood, Randall :** a Southwark resident.

**Wood, Richard :** father of Thomas Wood; a Southwark resident.

**Woodin, Woodine or Woodye, Will. :** Alleyn's cook.

**Woodward :** According to Ormiston, Woodward (first name unrecorded) was admitted to DC as a boarder, not a Poor Scholar, on 12/9/1620, and left before 13/1/1620[21].

**Worsip, Worsup, Worship, Mr :**

**Wright, Widow or Goody :** On 6/10/1617 Alleyn 'sent goody wright 5', but deleted the entry. He paid her 5s 9d for 'denshering' 26 rods (143 ft) on 14/10/1617. Widow Wright and Widow Barratt dined with Alleyn on 14/12/1617. Probably an undocumented Dulwich resident.

**Yarwood, Mr :** Richard Yearwood, a Governor of St Saviour's Grammar School; mentioned in Muniment 164.

**Yelverton, Sir Henry :** Attorney General 1617-1620. Alleyn paid him a visit in connection with the Letters Patent on 8/7/1618.

**Yeomans, Yeomands, Mr :** Possibly Stephen Yeomands, a Southwark resident, or more likely William Yeomans, married Agnes Brayton [Braxton] at St Saviour's, Southwark (Denmark Park) on 2/2/1594[95], and had at least two children. Later of Sydenham.

**Young, Mr :** Edward Young, DC chaplain and schoolmaster. Rev. Edward Young, Second (Schoolmaster) Fellow from 20/6/1617. Left 29/9/1618. On 1/1/1617[18] Alleyn paid 'Mr: Younge' his quarter's wages of £5.

**Young :** On 31/10/1617 Alleyn had supper at 'yongs ordinarie' with the Star Chamber men. (An 'ordinary' was a tavern offering food, drink, and accommodation.)
